<u>Treasurer's Report - Rosemary Smurthwaite</u>

The club has 106 golfers and 17 social members.

Beginning balance as of 9/1/25 was \$9,861.54 and balance as of 9/30/25 was \$7,523.92. Income primarily consisted of performance ticket sales and awards scramble green fees. Expenses consisted primarily of play payouts and banquet catering fees.

Room Set Up Fees – Joanne Stuvick

The room set up fee at the dining room has increased to \$53.00 per hour.

Committees are encouraged to do as much of the work they can to save on this expense.

Rules Solution Proposal – Bonnie Bohm

Bonnie proposed a change to the scorecard to comply with Rule 3.3. The proposal requires that the team scorer sign the scorecard, and each player must now either sign or initial on the team member line to indicate that she agrees to the results recorded for her on that scorecard. A sample of the proposed new scorecard was distributed to everyone in attendance.

A vote was held to change the scorecard to reflect these changes. Motion was made by Bonnie Bohm and seconded by Mindy Bergquist. Motion was carried. `
