Secretary's Report - Chris Sutton

Motion to approve the 7/11/25 minutes was made by Bonnie Bohm and seconded by Debbie Schwindt. Motion was carried

Treasurer's Report - Rosemary Smurthwaite

One new golfer was added since the last meeting. Total golfers are now 105.

Beginning balance as of July 1, 2025, was \$10,371.02 and ending balance as of July 31, 2025, was \$10,299.68. Income was primarily from the scramble lunch fees and green fees and expenses were primarily for catering and green fees.

New Business – Joanne Stuvick

Joanne suggested a way to solve ties at the scrambles.

Example: There are 3 teams tied for first place. You combine first second and third place money. Therefore, you have 3 first place winners.

Another example would be one team in first place. They share the 1st place money. You have 2 teams tied for second place. You would combine 2 and 3rd place money and split it between the 2 teams. You then have one first place winner and two second place winners.

It was also recommended that winners of the scramble, go to the podium, state their names and be recognized

There was a general agreement to these ideas.

<u>Vice President – Bonnie Bohm</u>

Bonnie mentioned that she will talk about Rule 3.3. at the General Meeting after the August Scramble.

Rule 3.3 – Each player is responsible for recording their individual hole scores on their own scorecard. At the same time, the player with the master scorecard is responsible for recording the individual hole scores of all players in the group. At the end of the game, each player must certify that the individual hole scores on the master scorecard matches what she has on her own scorecard. Each player will indicate her agreement by initialing the master scorecard. The master scorecard will be signed by the master score keeper and signed and attested to by another member of the group.

In order to remind all players of this rule, a notice of this rule will be attached to the master scorecard on play days.

Enforcement of Rule 3.3 will not be done this year in our group.
